**CIRCULAR**

It is hereby notified to all concerned that the Bar Council of Rajasthan in its General Meeting held on 29/07/2012 has decided to enforce the "**Renewal of Certificate of Practice Rules, 2006**" w.e.f. **29<sup>th</sup> July, 2012**, which was previously kept in abeyance. These Rules will be applicable to all the Advocates whose names appear on the State Roll maintained by this State Bar Council under section 17 of the Advocates Act, 1961.

Under these Rules, every Advocate whose name appears on the roll of this State Bar Council shall be required to get his/her certificate of practice renewed with this State Bar Council after every 5 years from its original registration or last renewal within 6 months from the date of enforcement of these Rules.

Advocates who have not completed 5 years, shall be required to apply within one month in advance of completion of such period of 5 years or every such subsequent period of 5 years, thereafter for the renewal of Certificate of Practice. The period of practice as an Advocate shall be reckoned from the date of enrolment.

It is further notified that every Advocate is required to apply for renewal of his/her certificate of practice in the prescribed form accompanied by an affidavit/declaration duly attested by President/Secretary of concerned Bar Association or Member of the Bar Council alongwith two latest passport size Photos and Cash/ D.D. of Rs. 200/- (Rs. Two hundred only) in favour of "Secretary Bar Council of Rajasthan" payable at Jodhpur as renewal fee.

The applications accompanied with documents and renewal fee of Rs. 200/- must reach in the office of the Bar Council of Rajasthan, Jodhpur **on or before 31/12/2012** by registered post or by hand. A copy of Renewal of Certificate of Practice Rules 2006 alongwith Prescribed application form is enclosed for your kind perusal and record. Those Advocates who have previously applied for Renewal, need not to apply again.

An Advocate who does not get his certificate renewed shall not be entitled to appear in any Court, Tribunal or before any authority or person in India.

You are requested to kindly place the Circular on the Notice Board of your Bar Association and circulate amongst the Members of your Bar for wide publicity, so that the Advocates may apply for renewal of his/her Certificate of Practice in time.
