NOTICE OF ELECTION 2018

UNDER RULE 6 OF THE BAR COUNCIL OF RAJASTHAN ELECTION RULES, 1968

It is hereby notified that the election of 25 Members of the Bar Council of Rajasthan will be held on **WEDNESDAY, the 28th MARCH, 2018** of whom not less than 13 (thirteen) shall be persons who have, for at least 10 years, been Advocates on the State Roll on the last date of filing nomination papers in accordance with the system of proportional representation by means of single transferable vote from amongst Advocates on the Electoral Roll of the Bar Council of Rajasthan according to Election Rules applicable to election of State Bar Council.

It is hereby further notified that the process of Filing of Nominations by the candidates for election as a Member of the Bar Council shall be started from **THURSDAY, the 01st FEBRUARY, 2018**. Every candidate for election as a Member of the Bar Council shall be proposed by a voter and seconded by another voter in form "A" (under rule 8 of the Bar Council of Rajasthan Election Rules) as given in the "Annexure". The last date for the receipt of Nomination papers is **THURSDAY, the 15th FEBRUARY, 2018 upto 4.00 P.M.** The Nomination paper shall be accompanied with a deposit of **Rs.10,000/-** (in Cash or by Bank Draft) in favour of "**Secretary, Bar Council of Rajasthan, Jodhpur**". Cheques will not be accepted. The deposit will be forfeited in case the candidate is unable to secure at least 1/6th of the quota fixed for being elected. The Scrutiny of the Nomination papers will be held on **THURSDAY, the 15th FEBRUARY, 2018 at 04.00 P.M.** in the Office of the Bar Council of Rajasthan and the last date for withdrawal from contest will be **THURSDAY, the 22nd FEBRUARY, 2018 upto 3.00 P.M.** The final list of candidates will be published on **THURSDAY, the 01st MARCH, 2018**. The scrutiny and counting of votes, unless otherwise notified, will commence in the Bar Council, High Court Campus, Jodhpur on **THURSDAY, the 12th APRIL, 2018 at 11.00 A.M.** and ordinarily be continued as far as possible, until all the results are announced. The candidates will be deemed to have been elected as Members of the Bar Council on the date of publication of their names in the Rajasthan Rajpatra.

In the event of election being contested the Advocates on the said Electoral Roll shall cast their votes in person between **9.00 A.M. to 5.30 P.M.** on the date of polling i.e., on **WEDNESDAY, the 28th MARCH, 2018** at the places as entered in the Electoral Roll/Voter List. All proceedings are subject to order of the Hon'ble Court.
