CIRCULAR

It has been observed that the Bar Associations in Rajasthan are not properly complying with the duties imposed upon them under Section 15(1) read with Section (2) of the Rajasthan Advocates Welfare Fund Act, 1987 i.e. to intimate/furnish the informations as mentioned in the said Section.

I am quoting Section 15 of Rajasthan Advocates Welfare Fund Act, 1987 which reads as under: -

"15. Duties of Bar Associations. - (1) Every Bar Association shall, on or before the 15th day of April of each year, furnish to the Bar Council and the Trustee Committee, a list of its members as on the 31st March of that year.


(2) Every Bar Association shall intimate to the Bar Council and Trustee Committee about, -

- (a) any change of the office bearers of the association within fifteen days from such change;
- (b) any change in the membership including admissions and re-admissions (and the change in the address of the member) within thirty days of such change;
- (c) the cessation of practice of voluntary suspension of practice (or death) of any of its members within thirty days from the date of such cessation or suspension of practice (or death);
- (cc) undertaking of any other business, profession or vocation by any of its members as soon as it comes to the knowledge of the Bar Association; and
- (d) such other matters as may be required by the bar council or the Trustee Committee from time to time.

It is, therefore, enjoined upon all the Bar Associations to strictly comply with the duties as laid down under Section 15(1) read with Section (2) of the Rajasthan Advocates Welfare Fund Act, 1987.

Further, if any Bar Association is not registered under the Rajasthan Societies Registration Act, 1958, it is requested to get the registration done under the Societies Act and comply with the proviso of Section 14 of the Rajasthan Advocates Welfare Fund Act, 1987.


