**Sub : Bar Council of India Certificate and Place of Practice
(Verification) Rules, 2015.**

Sir,

Your kind attention is invited towards this office earlier letter No.BCR/BA/Ju/2015/813 dated 29.1.2015 vide which you were informed that 'Bar Council of India has framed the rules, namely the Bar Council of India Certificate and Place of Practice (Verification) Rules, 2015', which was published in the Gazette of India in the Extra Ordinary Gazette Part 3, Section IV on 13.1.2015.

Under these rules, every advocate entered on the roll of this State Bar Council is required to apply for verification of "Certification of Practice and Place of Practice" in the prescribed form along with the verification fee/process fee of Rs.100/- (Rs.One Hundred only) within a period of 6 months of the enforcement of these rules/date of enrolment.

Your kind attention is also invited towards the Rules 10 and 11 of the Bar Council of India Certificate and Place of Practice (Verification) Rules, 2015, which reads as under :-

10. Delayed application with late fee:

That all the applications for verification of certificate of practice filed after the time fixed by rule 8/rule 9.1 of these rules shall not be received by the office/secretary unless it is accompanied by late fee in the sum of Rs. 100/- (one hundred only) and such late applications would be entertained only for a period of six (6) months.

11. Delayed application for verification with penalty clause :

That all applications for verification of certificate of practice filed after the period fixed under rule 10 shall not be received and processed by the office/secretary unless it is accompanied by a penalty fee of Rs.50 (rupees fifty only) per month reckoned from the last date on which such an application ought to have been made under Rule 10 of these Rules but such late application with penalty clause attached thereto would be entertained only for a period of six (6) months.
