Sub.: Withholding/Cancellation/Deferring of the elections including the schedule of elections of office bearers including Chairman, Vice-Chairman and four Co-Chairman of Rajasthan State Bar Council and Member-Representative to Bar Council of India from State Bar Council of Rajasthan scheduled for 5<sup>th</sup> August, 2018 and 12<sup>th</sup> August, 2018 respectively which had been sent by way of the above two referred letters.

Sir,

This is to bring to your kind knowledge that the office of the Bar Council of India is in receipt of information/complaints by certain newly elected members of the Bar Council of Rajasthan whereby they have raised strong averments and allegations relating to infighting, horse trading, usage of unconstitutional means including muscle power, threat of abduction, threat of life, threat of bodily harm, usage of money power/offer of money, corruption, unscrupulous, inducement/enticement, and external pressure including pressure from bogus law colleges, goons and mafia and certain bar councilors to cast vote in favour of a particular group candidates in the elections of the office bearers of the Bar Council of Rajasthan and member representative to Bar Council of India which was scheduled to be held on 05.08.2018 and on 12.08.2018 respectively at Bar Council of Rajasthan office/premises at Jodhpur.

Requests have been received to stop/defer the election and conduct an independent probe in this regard.

Thus in the light of serious issues/complaints which have been received by the Bar Council of India, it is thought proper to defer the elections of office bearers of the Bar Council of Rajasthan scheduled for 05.08.2018 and the election of the Member Representative of the Bar Council of India from the Bar Council of Rajasthan scheduled for 12.08.2018 to some other date till an enquiry/probe is conducted in this matter.

Therefore the Bar Council of India by way of this letter, hereby withdraws all the previous letters referred to above whereby the schedule of elections of the post of office bearers of the Bar Council of Rajasthan and elections to Member Representative to Bar Council of India was sent.

Thus kindly note that the election of bearers of the Bar Council of Rajasthan which was scheduled to be held on 05.08.2018 and the elections of the Member Representative to the Bar Council of India from the Bar Council of Rajasthan which was scheduled to be held on 12.08.2018 is hereby withheld, withdrawn, annulled, cancelled and deferred for the moment to some other date till an enquiry/probe is conducted in this matter.

The Hon'ble Advocate General is requested to kindly provide his comments with regard to the nature of the serious allegations and complaints which have been narrated above.

The details relating to the committee being appointed to enquire/probe into these serious allegations and dates of hearing/sitting of the Committee shall be intimated in due course.
