V/s Union of India &Ors., in the matter of gross under representation of women, the queer, the queer community, especially abled persons, persons from SC & ST and other marginalized strata of society in the Bar Council of India and State Bar Councils. The next date in the aforesaid case is tentatively fixed on 05.11.2024.

The Secretary apprised that the office has received a Notice from Hon'ble Supreme Court of India in Writ Petition (Civil) No.581 of 2024 (PIL) Ms. Yogamaya M.G. V/s Union of India & Ors., in the matter of gross under representation of women, the queer, the queer community, especially abled persons, persons from SC & ST and other marginalised strata of society in the Bar Council of India and State Bar Council. The date of the case is tentatively fixed on 05.11.2024.

He further apprised that the office has also received a Notice from Hon'ble Rajasthan High Court, Jaipur Bench, Jaipur in DB (PIL) No.16133/2024 Hema Tiwari V/s Bar Council of Rajasthan & Ors. The next date of hearing of the aforesaid case is fixed on 07.11.2024.

He requested to engage the Counsel in the interest of the Council in the Hon'ble Supreme Court of India as well as Hon'ble Rajasthan High Court, Jaipur Bench, Jaipur on behalf of the Bar Council of Rajasthan.

The Committee considered the matter and after consideration decided that there is no need to engage a Counsel in the Hon'ble Supreme Court of India for the time being. As and when necessity arose, the Bar Council will engage the Counsel in the Hon'ble Supreme Court of India to plead the case on behalf of the Bar Council of Rajasthan. As regards, the Notice received from Hon'ble Rajasthan High Court, Jaipur Bench, Jaipur in DB (PIL) No.16133/2024 Hema Tiwari V/s Bar Council of Rajasthan, the Committee decided to engage Shri Prateek Kasliwal, Advocate of Jaipur Counsel to plead the aforesaid case on behalf of the Bar Council of Rajasthan.

The Secretary is directed to provide copy of the Notice, related papers and Vakalatanama to Shri Prateek Kasliwal, Advocate of Jaipur at the earliest.

Item No. 06 of the Agenda:

To consider the Report of the Selection Committee in the matter of interview held on 13.10.2024 for the One post of Office Assistants (LDC) in the office of the Bar Council of Rajasthan, Jodhpur.

It was apprised by the Secretary that the interview for the One post of Office Assistant (L.D.C.) in the Office of the Bar Council of Rajasthan was held as per scheduled on 13.10.2024. The advertisement for above post was published on 01/07/2024 and the last date for submitting the application was kept as 15/07/2024. Total 13 candidates applied for the post of Office Assistant (LDC).

He further apprised that the Selection Committee submitted the Report. He placed the Report before the Members of the Committee.

The Committee perused the Report and recommendations of the Selection Committee and approved the recommendations for selecting Shri Kanwar Lal S/o Shri Jasu Ram for the post of Office Assistant (LDC) in the Grade of 5200-20400 (PB-1) L-5 (20800-36400).

The Committee directed that the appointment letter be issued to the Selected Candidates stating that the period of probation will be of three months from the date of joining and the selected candidates may join the duties on or before 14th of November, 2024. The recommendations of Selection Committee will be valid for three months from the date of interview.

Item No. 07 of the Agenda:

To consider the Report of the Selection Committee submitted by the Selection Committee in the matter of interview held on 13.10.2024 for the One post of Office Assistant (LDC) at the Advocates Bhawan, Jaipur.

It was apprised by the Secretary that the interview for the One Post of Office Assistant (L.D.C.) at the Advocates Bhawan, Jaipur was held as per scheduled on 13.10.2024. The advertisement for the above post was published on 28/08/2024 and last date for submitting the application was kept as 12/09/2024. Total 21 candidates applied for the above post.

He further apprised that the Selection Committee submitted the Report. He placed the Report before the Members of the Committee.

The Committee perused the Report and recommendations of the Selection Committee and approved the recommendations for selecting Shri Rajdeepak Sharma S/o Shri Prajesh Sharma for the post of Office Assistant (LDC) at the Advocates Bhawan, Jaipur in the Grade of 5200-20400 (PB-1) L-5 (20800-36400).

The Committee directed that the appointment letter be issued to the Selected Candidate stating that the period of probation will be of three months from the date of joining and the selected candidates may join the duties on or before 14th of November, 2024. The recommendations of Selection Committee will be valid for three months from the date of interview.

Item No. 08 of the Agenda:

To consider the application of Shri Dev Prakash Vyas, Office Assistant (Retd.) with regard to provide him the benefit of 7th Pay Commission, as per the rules.

The Committee considered the matter and after consideration decided that the applicant retired from the service of the Bar Council of Rajasthan prior to implementation of 7th pay commission in the Bar Council of Rajasthan, therefore, he is not entitled to receive any benefit of 7th pay commission, hence, rejected the same.

Item No. 09 of the Agenda:

Any matter by the Chairman or with the permission of Chair.

(1) To consider the representation of staff members of the Bar Council of Rajasthan for granting annual bonus.

The Members of the Committee considered the matter and after consideration decided that on the occasion of Deepawali festival, equal to one month's salary be granted as annual bonus to all the staff members of the Bar Council of Rajasthan, who have worked during the financial year 2023-24, whether permanent or temporary on fixed salary basis.

(2) The Secretary apprised that the office has received the letter dt.25.09.2024 from Bar Council of India, New Delhi about the strict compliance and verification of candidates - Adherence to Bar Council of India directives prior to enrolment. He read over the letter before the Hon'ble Members of the Committee.

He requested the Hon'ble Members of the Committee to issue necessary guidelines/directions in this regard in light of the aforesaid letter, so that the office can take further course of action in the enrolment applications received from the candidates.

The Committee considered the matter and after consideration decided that the applicants whose enrolment applications have been received in the office after the 25.09.2024, they need to submit police verification certificate from the concerned police station. However, the applicants whose enrolment applications have been received prior to 25.09.2024, they don't need to submit police verification certificate

from the concerned police station and they may be enrolled as per the past practice.

The Office is directed to comply with the decision taken by the Executive Committee today and convey the same to Hon'ble Members of the Enrolment Committee.

The Meeting was then terminated with a vote of thanks to the chair.
