

The Electoral Roll/Voter List for the ensuing election, will not be subject to further change except on account of disqualifications from voting or correction on account of typographical error or on account of order passed by the competent court. In such eventuality necessary correction will be notified and published on Notice Board of the Bar Council of Rajasthan and intimated to the Polling Officers concerned and the right to vote will accrue only when the name appears in the Electoral Roll / Voter List as mentioned hereinabove or on the basis of any order passed by Hon'ble Court or Bar Council of India.

The Electoral Roll / Voter List will remain open for inspection in the Office of the Bar Council of Rajasthan during office hours on all working days i.e., from 10.30 A.M. to 5.00 P.M.

It is further notified that a copy of the Electoral Roll / Voter List (for entire State /Judgship wise) (photo stat on one side of the paper) will be available on the payment of cost fixed by the office.
