Sirs/Ma'ams,

The Hon'ble Chairman BCI has written a letter to the Hon'ble Prime Minister of India on 22.01.2019, wherein on behalf of the Bar, certain welfare measures like insurance, mediclaim, pension, stipend for young lawyers, etc has been claimed/demanded from the Government for Advocates and their families.

In this light of this, this is to bring to your kind and urgent attention that as per direction issued, **all State Bar Councils are requested to convene an emergent meeting of their council at the earliest. The meeting may kindly place the letter which is attached with this email and which was sent by Hon'be Chairman, BCI to Hon'ble Prime Minister before all the Hon'ble members of the State Bar Councils.**

The Hon'ble members may peruse and read the contents of the said letter and pass a resolution supporting these demands and the letter of B.C.I.

The S. B. Cs. should also send the copies of resolutions so passed by them to all the Bar Associations along with forwarding them to BCI

✓ There will be a Joint meeting of all the State Bar Councils, High Court Bar Associations and Cordiation Committee of Delhi and N. C. R. Bar Associations in the premises of B.C.I. on 2nd February 2019.

All the Bar Councils may kindly send 2 members from their Bar Councils.

The High Court Bar Associations should also send Two representatives for this joint meeting

The travelling expenses of representative members/ office bearers will be borne by concerned State Bar Council/s and High Court Bar Associations.

The local transportation, fooding , lodging shall be managed by B.C.I.

Agenda of the meeting would be to fix a date , route , venue and other details of demonstrations / protest march by Advocates in support of their demands (if the Govt. doesn't accept it).

All the State Bar Councils should pass these resolutions and send it to P. M. O. and Hon'ble Finance Minister with copy to BCI. The Bar Associations should be also asked to send a letter in support of such resolutons to the P.M.O and Hon'be Finance Minister
