Sub : Continuing Legal Education Programme for young advocates organized by Bar Council of Rajasthan alongwith National Law University, Jodhpur from **26th June, 2014 to 29th June, 2014 (4 Days)**.

Dear Sir,

You will be glad to know that in order to discharge one of its pious duties, the General House of the Bar Council of Rajasthan has decided to impart continuous legal education to the members of the Bar.

In this respect, it has been considered that initially new entrants will be imparted this education and, therefore, it has also been decided that the advocates who have put in practice upto 5 years and not completed the age of 35 years should be given this continuous legal education, so as to acquaint them with procedural law and other laws. It has also been decided that this programme may be undertaken in coordination with the National Law University, Jodhpur.

The Executive Committee of the State Bar Council has also laid down the criteria for selecting the advocates from all over Rajasthan. As per the criteria laid down, from your District, 10 lawyers are required to be selected who will be provided education in 2 batches of 4 days each. For this purpose selected lawyers will be required to remain at Jodhpur. Entire expenditure of lodging, boarding and study material will be borne by the Bar Council. However, the concerned advocate will be required to contribute a sum of **Rs. 200/-** only for 4 days programme.

You are, therefore, requested to send the names of desired candidates, alongwith application, through your District Bar Association, so as to reach the Bar Council on or before 31.05.2014. If any member of the Bar Council is there, then names are to be sent in consultation with him. If the applications received are large in number, you may arrange them in order of preference on the basis of length of practice with a further criteria of marks obtained by them in law examination. On being selected, candidates will be required to send the amount in advance to the State Bar Council by D.D. for which intimation shall be sent to you or the concerned Advocate as the case may be, by the office of State Bar Council. Please do not forward applications of such candidates who have already attended the said programme.

This is the Twelfth attempt for uplifting the standard of profession by this system and I am sure that you will extend full cooperation in the matter. Please undertake the exercise as early as possible and send the names of selected candidates to the State Bar Council. I may inform you that the education will be imparted during summer vacations, hence Complete attendance during the entire training period is necessary otherwise no certificate of such training will be awarded. Apart from faculty members of National Law University, Jodhpur, we will try to get lectures from Hon'ble Judges and eminent Advocates.

The other details of the programme will be communicated to the participants directly.

I also request you to give your valuable suggestions for making this programme effective and successful.
