Kindly note that the last date for deposit of fee for All India Bar Exam has been extended from 3rd September to 5th September, 2019 by the Monitoring Committee of the Bar Council of India chaired by Jusrice Gyan Sudha Mishra Former Judge Supreme Court of India.

This was done while considering the request of Jharkand State Bar Council to reschedule the date of examination which was not acceded to, but extension of date of deposit of fee was granted.

Kindly bear in mind that the registration date/form submission date for AIBE was 1st September, 2019 and the said date has not been extended by Monitoring Committee after due discussion and deliberation.

Therefore only candidates who have filled up the examination form and have not yet paid the fee online, have been given an opportunity to pay the same by 5th September, 2019.

The Committee deliberated upon the request by UP State Bar Council Chairman to extend/reschedule the date of examination form 15th September, 2019 due to lower judicial exam being held in the State on such date, but this being an All India Level

Exam, and considering the stage at which things stand as of now, the request could not be acceded to.

Furthermore another request from Executive Member Gujrat Bar Council to extend the dates for those candidates who have not been enrolled as Advocates due to pending verification of their degrees with Universities was also not acceded to as AIBE exam is not a qualifying exam and is required to be cleared within 2 years of enrolment, and enrolled Advocates would get ample time after enrolment to clear such exam.
